ORDER

Case No. 17-cv-405-wmc

Plaintiff Charles Sheppard has filed a proposed civil complaint, which was transferred to this court from the Eastern District of Wisconsin. Plaintiff has neither paid the filing fee nor requested leave to proceed without prepayment. For this case to proceed, plaintiff must pay the \$400 filing fee or submit a properly supported motion for leave to proceed without prepayment of the filing fee no later than June 16, 2017.

A motion for leave to proceed without prepayment of the filing fee must be accompanied by a certified copy of plaintiff's inmate trust fund account statement (or institutional equivalent) for the six-month period immediately preceding the date of the complaint. 28 U.S.C. § 1915(a)(2). If I find that plaintiff is indigent, I will calculate an initial partial payment amount that must be paid before the court can screen the merits of the complaint under 28 U.S.C. § 1915(e)(2). Thereafter, plaintiff will be required to pay the balance of the filing fee in installments.

ORDER

IT IS ORDERED that plaintiff Charles Sheppard may have until June 16, 2017 to submit the \$400 filing fee or a motion for leave to proceed without prepayment and a trust

fund account statement for the period beginning approximately November 23, 2016 and ending approximately May 23, 2017. If, by June 16, 2017, plaintiff fails to respond to this order, I will assume that plaintiff wishes to withdraw this action voluntarily. In that event, the case will be closed without prejudice to plaintiff filing the case at a later date.
