PER CURIAM.

This case is on remand from the Florida Supreme Court, which quashed our prior decision and directed reconsideration in view of its recent decision in *Giraldo v. Agency for Health Care Administration*, 248 So. 3d 53 (Fla. 2018).

In *Giraldo*, the Florida Supreme Court held that federal law allows the Agency for Health Care Administratiom (AHCA) to lien only the past medical expenses portion of a Medicaid beneficiary's third-party tort recovery to satisfy its Medicaid lien. *Id.* at 56. Therefore, in accordance with the mandate from the supreme court, this cause is remanded to the Administrative Law Judge to reduce the awarded amount to \$20,717.54 for satisfaction of AHCA's lien.
