We reconsider on remand our opinion in *Govoni v. State*, 17 So. 3d 809 (Fla. 4th DCA 2009), which was quashed by the Florida Supreme Court following its decision in *Govoni v. State*, 36 Fla. L. Weekly S365 (Fla. July 7, 2011). As ordered by the Supreme Court, we apply its decision in *Dennis v. State*, 51 So. 3d 456 (Fla. 2010), approving *Peterson v. Accordingly, we grant the petition for writ of prohibition and direct the trial court to follow the procedure set forth in *Dennis*.
