On Confession of Error

SUAREZ, J.

Based on the Appellee's proper confession of error and our own independent review of the record, we reverse the trial court's non-final order compelling

appraisal and remand for an evidentiary hearing to determine whether post-loss obligations were sufficiently met under the policy. See Citizens Prop. Ins. Corp. v.
