WRIT GRANTED. We reverse and vacate the January 14, 2013, February 19, 2013, March 1, 2013, April 18, 2013, April 29, 2013, and June 17, 2013 orders of the trial court that authorized either the Sheriff of East Baton Rouge Parish or Livingston Parish to deposit ad valorem taxes collected for the Amite River Basin Drainage and Water Conservation District into the registry of the court to the extent that the sums deposited do not represent taxes actually paid under protest. It is Ordered that any funds deposited pursuant to the mandates of the now-vacated orders be immediately released to the Amite River Basin Drainage and Water Conservation District, except insofar as such funds were actually paid under protest.

VGW WJC MRT

WELCH AND HIGGINBOTHAM, JJ., dissent and would deny the writ, declining to exercise this Court's supervisory jurisdiction because we conclude that the criteria set forth in Herlitz Construction Company, Inc. v. Hotel Investors of New Iberia, Inc., 396 So.2d 878 (La. 1981) are not met.
