WRIT DENIED ON THE SHOWING MADE. As presented, the writ application does not allow this court to adequately review the district court's ruling herein. Relator alleges the district court denied his Motion to Record Grand Jury Proceedings on March 1, 2018. Initially, we note that while relator included a copy of the motion in the application, the last page of the motion containing the order is blank. Relator has not provided a copy of the court's ruling on the motion, the indictment, pertinent court minutes, and any opposition to the writ application or a statement that there was no such opposition. application or a statement that there was no such opposition. See Uniform Rules of Louisiana Courts of Appeal, Rules 4-5(C)(6), (8), (9), & (10). Furthermore, while relator states the "application is timely filed as no return date was set," he does not indicate that he filed a notice of intent and/or that the district court failed to set a return date. See Uniform Rules of Louisiana Courts of Appeal, Rules 2-13, 4-2, 4-3, & 4-5(C)(11). There are no telephone numbers provided in the affidavit for the district court judge or the district extreme affidavit for the district court judge or the district attorney, and the entire writ application (including exhibits) does not have consecutively-numbered pages. See Uniform Rules of Louisiana Courts of Appeal, Rules $4-5\,(\hbox{A})$ & (B). Finally, we note that while it is not a violation of the Uniform Rules of Louisiana Courts of Appeal, relator has not included a transcript of the proceedings from March 1, 2018 (wherein the motion was allegedly denied), see City of Baton Rouge v. Plain, 433 So.2d 710 (La.), cert. denied, 464 U.S. 896, 104 S.Ct. 246, 78 L.Ed.2d 235 (1983), or an allegation that the motion was denied without a hearing.

Supplementation of this writ application and/or an application for rehearing will not be considered. See Uniform Rules of Louisiana Courts of Appeal, Rules 2-18.7 & $\overline{4-9}$. In the event relator elects to file a new application with this court, due to the time constraints involved, he may do so without the necessity of obtaining a return date, the application should comply with the requirements of Rule 4-4 (concerning requests for expedited consideration), and the application must be filed and received by 4:00 p.m. today, March 8, 2018. Additionally,
