## LOBRANO, J., DISSENTS WITH REASONS

I respectfully dissent. I would vacate the trial court's ruling that granted the defendant's motion to quash the August 22, 2013 indictment. I would remand this matter for further proceedings to allow the trial court to determine whether the August 22, 2013 indictment<sup>1</sup> was implicitly dismissed by the superseding indictment filed on August 29, 2013 against the defendant, which was the subject matter in *State v. Jones*, 2014-0014 (La. App. 4 Cir. 6/11/44), --So. 3d --, 2014 WL 2619915.<sup>2</sup> *See State v. Williams*, 2012-687, p. 3 (La. App. 5 Cir. 5/16/13),119 So. 3d 228, 230 (where the court held that a "superseding indictment implicitly dismisses a first indictment.").
