O'CONNELL, J. (concurring in part, dissenting in part.)

I concur with parts I and II of the majority opinion that class certification was properly granted by the trial court. I write separately to say that leave to appeal in this case was imprudently granted on the balance of the issues before this Court. I note that leave to appeal was originally denied by this Court. Unfortunately, the Supreme Court remanded this case to be heard as on leave granted. *Creech v W.A. Foote Mem'l Hosp, Inc*, 456 Mich 887; 636 NW2d 138 (2001). Other than the class certification issue, none of the issues in this case are ripe for a motion under MCR 2.116(C)(10). The balance of the issues need further record development before this Court can properly render a decision on the merits of these issues.

Other than the trial court's order certifying this matter as a class action, I would vacate the trial court's orders in regard to parts III and IV of the majority opinion, and I would remand

the case to the trial court for further proceedings. Once the lower court record is further developed, the parties are free to refile their motions for summary disposition.²
