**CORRECTED ORDER AMENDING AND ADOPTING MASTER'S REPORT**

Pursuant to Montana Code Annotated, § 85-2-233(5), the above entitled case was assigned to Water Master Julia Nordlund. The Water Master filed a report containing Findings of Fact and Conclusions of Law with the Clerk of Court. Copies of the report were served upon the parties on January 13, 2023. Claimant Peter Zeliff filed an Objection to the Master's Report on January 27, 2023. The Order Amending and Adopting Master's Report dated February 7, 2023, made the requested corrections. On February 8, 2023, Peter Zeliff filed an additional Objection to the OAA.

The Objection pointed out a typographical error on the abstract of claim 41H 30155788. The priority date should be corrected from June 1, 1982 to June 1, **1882**.

The Court has reviewed the Water Master's Findings and Conclusions. Pursuant to Rule 53(e), Montana Rules of Civil Procedure, the Court **ADOPTS** the January 13, 2023 Master's Report with the corrections in the February 7, 2023 Order Amending and Adopting, and

**ORDERS** that **Post Decree Abstract of Water Right Claim 41H 30155788** be served with this Order to confirm that the recommendations set forth in the Master's Report, as amended by this Order, have been adopted.
