This Master's Report was filed with the Montana Water Court on the above stamped date. Please review this report carefully.

You may file a written objection to this Master's Report within **10 days** of the stamped date if you disagree or find errors with the Master's findings of fact, conclusions of law, or recommendations. Rule 23, W.R.Adj.R. If the Master's Report was mailed to you, the Montana Rules of Civil Procedure allow an additional 3 days be added to the 10-day objection period. Rule 6(d), M.R.Civ.P. If you file an objection, you must serve a copy of the objection to all parties on the service list found at the end of the Master's Report. The original objection and a certificate of mailing to all parties on the service list must be filed with the Water Court.

If you do not file a timely objection, the Water Court will conclude that you agree with the content of this Master's Report.

MASTER'S REPORT

The above-captioned claims appeared in the Preliminary Decree for the Judith River (Basin 41S) and received issue remarks placed on the claims during reexamination of the claims by the Department of Natural Resources and Conservation (DNRC). The claims are hereby consolidated into Water Court Case 41S-0242-R-2024 for the purposes of this Master's Report.

This Court is required to resolve issue remarks that are not resolved through objections. The claims received the following issue remarks:

Claim 41S 3442-00:

SOURCE NAME WAS MODIFIED AS A RESULT OF DNRC REVIEW UNDER MONTANA WATER COURT REEXAMINATION ORDERS. IF NO OBJECTIONS ARE FILED TO THIS CLAIM, THESE ELEMENTS WILL REMAIN AS THEY APPEAR ON THIS ABSTRACT AND THE REMARK WILL BE REMOVED FROM THE CLAIM.

Claim 41S 3454-00:

USDA AERIAL PHOTOGRAPH NO(S). 30027-278-64 , DATED 09/25/1979 , APPEARS TO INDICATE 30.50 ACRES IRRIGATED. A DESCRIPTION OF THESE ACRES IS IN THE CLAIM FILE.

Claims 41S 30116611, 41S 30116612, 41S 30116613, 41S 30116614, 41S 30116615, 41S 30116616, 41S 30116617:

THIS CLAIM NUMBER WAS NOT INCLUDED IN THE BASIN 41S DECREE ISSUED 05/17/1984.

The issue remarks on claims 41S 3442-00, 41S 30116611, 41S 30116612, 41S 30116613, 41S 30116614, 41S 30116615, 41S 30116616 and 41S 30116617 as well as the 'source name' remark on claim 41S 3454-00 are notice type remarks. The issue remarks do not raise unresolved issues nor require additional information to be resolved. The issue remarks state that if no objections were filed, the remarks would be removed. These claims did not receive objections or notices of intent to appear.

FINDINGS OF FACT

1. The issue remark on claim 41S 3454-00 discussing the acreage estimate was gleaned from a single aerial photograph take on September 25, 1979. The claimed period of use ends on October 1. The remark does not implicate the historical use of the claim.
2. The remaining remarks on the claims have served their purpose and should be removed as no further action is needed.

PRINCIPLES OF LAW

1. The Montana Water Court has the authority to determine the extent of all water rights in the state as they existed prior to July 1, 1973. *Fellows v. Saylor*, 2016 MT 45, ¶ 25, 382 Mont. 298, 367 P.3d 732; §§ 85-2-233, -102(13), MCA.

2. A properly filed Statement of Claim for Existing Water Right is prima facie proof of its content. § 85-2-227, MCA. This prima facie proof may be contradicted and overcome by other evidence that proves, by a preponderance of the evidence, that the elements of the claim do not accurately reflect the beneficial use of the water right as it existed prior to July 1, 1973. This is the burden of proof for every assertion that a claim is incorrect. Rule 19, W.R.Adj.R. A preponderance of the evidence is evidence that shows a fact is “more probable than not.” *Hohenlohe v. State*, 2010 MT 203, ¶ 33, 357 Mont. 438, 240 P.3d 628.

CONCLUSIONS OF LAW

1. The ‘acres irrigated’ issue remark on claim 41S 3454-00 should be removed as the issue remark fails to overcome the prima facie status of the claim in relation to historical use. Further, a single photograph taken at the tail end of the claimed irrigation season does not implicate abandonment of this claim.

2. The remaining notice type issue remarks on the claims should be removed as discussed above.

RECOMMENDATIONS

1. The issue remarks should be removed from the claims for the reasons discussed above and the claims should be decreed with the elements as they appeared in the Preliminary Decree.

Post Decree Abstracts of Water Right Claims are attached to this Master’s Report for review.
