**ORDER AMENDING AND ADOPTING MASTER’S REPORT  
AND  
CORRECTING OWNERSHIP**

Pursuant to Montana Code Annotated, section 85-2-233(5), Case 43B-1019-R-2021 was assigned to Water Master Anika M. Stern. A Master’s Report was issued on March 4, 2024. Claimant and Objector Brogan LP (Brogan) objected to the Master’s Report on March 21, 2024 requesting the ownership of claims 43B 193576-00 and 43B 193861-00 be corrected. Additionally, Brogan indicates none of the other parties in the Case object to the ownership correction.

Brogan explains that it was inexplicably removed as an owner of claims 43B 193576-00 and 43B 193861-00 and it objected to the claims during the 2019 Basin 43B objection period to remedy the ownership error:

9. State the changes you think should be made to this claim and why. State the specific grounds and evidence on which the Objection is based. (Use additional paper if necessary.) This water right was proportionally split between the Royal Teton Limited/Church Universal and Triumphant (now Western Shamballa Inc.) and Welch Brogan (now Brogan Limited Partnership) in the late 1980s. As indicated in documentation contained in the claim file, the water right was split with 70% going to the Church Universal and Triumphant, and 30% being retained by Welch Brogan. This proportional ownership was confirmed in the 1997 Master's Report adopted by the Water Court on October 10, 1997. Therefore, Brogan Limited Partnership should be listed as a co-owner on this water right.

Although the parties stipulated that Brogan should be added as a co-owner to claims 43B 193576-00 and 43B 193861-00, they failed to explain why the Court should update ownership, rather than the DNRC, and to provide support documentation; that information has now been provided.

Recommendation No. 1 should be amended to reflect that Brogan LP is added as a co-owner to claims 43B 193576-00 and 43B 193861-00. Post Decree Abstracts for claims 43B 193576-00 and 43B 193861-00 are also corrected to reflect the ownership corrections.

The Court has reviewed the Water Master's Findings and Conclusions. Pursuant to Rule 53(e), Montana Rules of Civil Procedure, the Court **ADOPTS** the Master's Report with the above-referenced amendment.

Corrected Post Decree Abstracts for claims 43B 193576-00 and 43B 193861-00 are served with this Order to confirm that the Recommendations set forth in the Master's Report, as amended by this Order, have been adopted for the claims in this Case.
