This is an action to recover damages for personal injuries arising out of an incident which occurred on October 2, 2018.

The summons and complaint were filed on January 14, 2019 against the original defendants. A third-party complaint was filed against Buildingrite, LLC, and Rise Concrete, LLC, on June 26, 2019. Thereafter, plaintiff determined that Buildingrite, LLC and Rise Concrete, LLC, were responsible parties to the main action.

In the absence of significant prejudice or surprise to the opposing party, leave to amend a pleading should be freely given (see CPLR 3025[b]; <u>Edenwald Contr. Co. v City of New York</u>, 60 NY2d 957[1983]; <u>Russo v Lapeer Contr. Co., Inc</u>, 84 AD3d 1344 [2d Dept. 2011]), unless the proposed amendment is palpably insufficient or patently devoid of merit (see <u>Bernardi v</u> <u>Spyratos</u>, 79 AD3d 684 [2d Dept. 2010]; <u>Martin v Village of</u> <u>Freeport</u>, 71 AD3d 745 [2d Dept. 2010], and provided the amendment does not prejudice or surprise the opposing party (see <u>Douglas</u> <u>Elliman, LLC v Bergere</u>, 98 AD3d 642 [2012]).

Here, there is no prejudice or surprise to Buildingrite, LLC, and Rise Concrete, LLC, because they are already in the action as the second third-party defendants.

No opposition has been filed.

Accordingly, it is hereby

ORDERED, that plaintiff's motion is granted and plaintiff is given leave to add Buildingrite, LLC, and Rise Concrete, LLC, as party defendants; and it is further
