UPON review of the Notice of Motion dated March 9, 2020; the Summons, Complaint and Notice of Pendency of this action filed on July 19, 2017; upon the Affirmation of David P. 

ORDERED, ADJUDGED AND DECREED, that the City Register of the City of New York, County of Kings, upon the payment of its requisite fees, shall record and index a certified copy of this Order against the real property described as Tax Block 7927, Lot 27, having an address of 819 East 51st Street, Brooklyn, New York 11203; and it is further

ORDERED, that a copy of this Order with Notice of Entry shall be served upon the owner of the equity of redemption, any tenants named in this action,
