Hence, this matter came to be heard before this panel of three commissioners on May 18, 2006 at 11:00 A.M.

 $\{\P 2\}$ Neither the applicant nor anyone on her behalf appeared at the hearing. An Assistant Attorney General attended the hearing and presented a brief statement for the panel's consideration. The Assistant Attorney General reiterated her position to deny the claim pursuant to R.C. 2743.60(E). The Case No. V2006-20160 -1- <u>ORDER</u> Assistant Attorney General requested that the Attorney General's Final Decision to deny the claim be affirmed.

 $\{\P 3\}$ From review of the file and with full and careful consideration given to all the information presented at the hearing, we find the January 25, 2006 decision of the Attorney General shall be affirmed.

IT IS THEREFORE ORDERED THAT

1) The January 25, 2006 decision of the Attorney General is AFFIRMED;
