ORDER OF A THREE-  
COMMISSIONER PANEL

---

{¶1} The applicant filed a reparations application seeking reimbursement of expenses incurred with respect to an alleged January 20, 2007 assault incident. On February 23, 2007, the Attorney General denied the claim pursuant to R.C. 2743.52(A) contending that the applicant failed to prove that she incurred economic loss. On March 5, 2007, the applicant filed a request for reconsideration. On March 12, 2007, the Attorney General denied the claim once again. On March 19, 2007, the applicant filed a

notice of appeal to the Attorney General's March 12, 2007 Final Decision. At 10:30 A.M. on June 7, 2007, this matter was heard before this panel of three commissioners.

{¶2} Neither the applicant nor anyone on her behalf appeared at the hearing. An Assistant Attorney General attended the hearing and presented brief comments for the panel's consideration. The Assistant Attorney General summarized the case and reiterated her position for denying the claim based upon the applicant's failure to prove she qualified as a victim of criminally injurious conduct, her failure to report the alleged incident to law enforcement, and her failure to prove she incurred economic loss.

{¶3} From review of the file and with full and careful consideration given to all the information presented at the hearing, we find that the March 12, 2007 decision of the Attorney General shall be affirmed.

{¶4} IT IS THEREFORE ORDERED THAT

- {¶5} 1) The March 12, 2007 decision of the Attorney General is AFFIRMED;
- {¶6} 2) This claim is DENIED and judgment is rendered for the state of Ohio;
- {¶7} 3) Costs are assumed by the court of claims victims of crime fund.
