ORDER OF A THREE-
COMMISSIONER PANEL

{¶1} The applicant filed a reparations application seeking reimbursement of expenses incurred with respect to various instances of alleged criminally injurious conduct. On April 24, 2007, the Attorney General denied the claim pursuant to R.C. 2743.52(A) contending that the applicant failed to prove he qualified as a victim of criminally injurious conduct. On April 25, 2007, the applicant filed a request for reconsideration. On May 30, 2007, the Attorney General denied the claim once again. On June 6, 2007, the applicant filed a notice of appeal to the Attorney General's May 30, 2007 Final Decision. On September 5, 2007 at 10:50 A.M., this matter was heard before this panel of three commissioners.

{¶2} Neither the applicant nor anyone on his behalf appeared at the hearing. An Assistant Attorney General attended the hearing and presented brief comments for the panel's consideration. The Assistant Attorney General summarized the case and reiterated her position for denying the claim.

{¶3} From review of the file and with full and careful consideration given to all the information presented at the hearing, we find that the May 30, 2007 decision of the Attorney General shall be affirmed.

{¶4} IT IS THEREFORE ORDERED THAT

- {¶5} 1) The May 30, 2007 decision of the Attorney General is AFFIRMED;
- {¶6} 2) This claim is DENIED and judgment is rendered for the state of Ohio;
- {¶7} 3) Costs are assumed by the court of claims victims of crime fund.
