In his Petition, Hill avers he is imprisoned in Madison Correctional Institution in London, Ohio. Because Petitioner Hill is not located within this Court's territorial jurisdiction, the instant cause of action must be dismissed for lack of jurisdiction. R.C. 2725.03 and *Bridges v. McMackin* (1989), 44 Ohio St.3d 135, 541 N.E.2d 1035. A petition for habeas corpus must be filed where the person being detained is physically located. *Id.*

{¶2} For this reason, the Motion for Judgment on the Pleadings is denied, and the Petition is dismissed.
