JOINT PETITION IN SUPPORT
OF DISCIPLINE ON CONSENT
PURSUANT TO Pa.R.D.E. 215(d)

Petitioner, the Office of Disciplinary Counsel by Paul J. Killion, Chief Disciplinary Counsel, and Harold E. Ciampoli, Jr., Disciplinary Counsel, and Respondent, George B. Ditter (hereinafter, "Respondent"), through his attorney, James C. Schwartzman, Esquire, file this Joint Petition In Support of Discipline on Consent Pursuant to Pennsylvania Rule of Disciplinary Enforcement ("Pa.R.D.E.") 215(d), and respectfully represent:

1. Petitioner, whose principal office is situated at Pennsylvania Judicial Center, 601 Commonwealth Ave., Suite 2700, P.O. Box 62485, Harrisburg, PA 17106 is invested, pursuant to

Pa.R.D.E. 207, with the power and duty to investigate all matters involving alleged misconduct of an attorney admitted to practice law in the Commonwealth of Pennsylvania and to prosecute all disciplinary proceedings brought in accordance with the various provisions of the aforesaid Enforcement Rules.

2. Respondent was born on September 7, 1950, and was admitted to practice law in the Commonwealth on October 26, 1976. His attorney registration number is 23199.

3. Respondent's public mailing address is 226 Hendrick Road, Perkiomenville, PA 18074.

4. On January 20, 2016, Petitioner and Respondent filed with the Supreme Court of Pennsylvania a Joint Petition to Temporarily Suspend an Attorney.

5. By Order dated February 12, 2016, the Supreme Court granted the Joint Petition and placed Respondent on temporary suspension.

6. Respondent is subject to the disciplinary jurisdiction of the Disciplinary Board of the Supreme Court.

SPECIFIC FACTUAL ALLEGATIONS ADMITTED

7. In October 2015, a partner in Respondent's law firm contacted Montgomery County law enforcement authorities and reported that he believed an employee in his office was

possessing and acquiring child pornography through the use of a firm computer.

8. On October 6, 2015, Montgomery County Detectives executed a search warrant at Respondent's law firm and discovered on Respondent's computer three hundred thirty images of children under the age of eighteen involving lewd exhibition of the genitals or nudity for the purpose of sexual stimulation or gratification for any person who may view such depiction.

9. On November 3, 2015, Respondent appeared before Magisterial District Judge Robert M. Sobeck and waived his preliminary hearing in connection with the pending charges against him.

10. On January 6, 2016, an Information was filed in the Court of Common Pleas of Montgomery County charging Respondent with ten counts of Sexual Abuse of Children (Possession of Child Pornography), 18 Pa.C.S.A. §6312(d), and one count of Criminal Use of a Communication Facility, Sexual Abuse of Children-Possession of Child Pornography, 18 Pa.C.S.A. §7512(a).

11. On November 4, 2016, Respondent entered a guilty plea before the Honorable Garrett D. Page, in the matter captioned: *Commonwealth v. George Bock Ditter*, Docket No. CP-46-CR-0008215-2015, Court of Common Pleas of Montgomery County.

12. Respondent entered into an open guilty plea to count

possessing and acquiring child pornography through the use of a firm computer.

8. On October 6, 2015, Montgomery County Detectives executed a search warrant at Respondent's law firm and discovered on Respondent's computer three hundred thirty images of children under the age of eighteen involving lewd exhibition of the genitals or nudity for the purpose of sexual stimulation or gratification for any person who may view such depiction.

9. On November 3, 2015, Respondent appeared before Magisterial District Judge Robert M. Sobeck and waived his preliminary hearing in connection with the pending charges against him.

10. On January 6, 2016, an Information was filed in the Court of Common Pleas of Montgomery County charging Respondent with ten counts of Sexual Abuse of Children (Possession of Child Pornography), 18 Pa.C.S.A. §6312(d), and one count of Criminal Use of a Communication Facility, Sexual Abuse of Children-Possession of Child Pornography, 18 Pa.C.S.A. §7512(a).

11. On November 4, 2016, Respondent entered a guilty plea before the Honorable Garrett D. Page, in the matter captioned: *Commonwealth v. George Bock Ditter*, Docket No. CP-46-CR-0008215-2015, Court of Common Pleas of Montgomery County.

12. Respondent entered into an open guilty plea to count

ten of the Information, sexual abuse of children, graded as a felony of the third degree.

13. The sentencing guidelines were calculated at three to twelve months. The Commonwealth agreed to ask for no more than three months incarceration at the time of sentencing.

14. Respondent's sentencing was deferred pending a Pre-Sentence Investigation and a Sexually Violent Predator Assessment to be completed by the Sexual Offenders Assessment Board.

15. The report of the Sexual Offenders Assessment Board concluded that Respondent did not qualify or meet the criteria to be classified as a sexually violent predator.

16. On March 20, 2017, Judge Page sentenced Respondent to intermediate punishment for a period of twenty-three months. The first three months were to be served under House Arrest, GPS monitoring. Respondent was also sentenced to probation for a period of five years, consecutive to parole. Respondent was fined \$1,000.00, ordered to perform seventy-two hours of community service and continue treatment with his Psychologist, Dean Dickson.

17. Mr. Dickson is a licensed psychologist and a member of the Sexual Offenders Assessment Board, Office of the Governor, Harrisburg, Pennsylvania. He operates treatment groups for

convicted sexual offenders referred from five Southeastern Pennsylvania counties and the Board of Probation and Parole in Allentown. Since October/November of 2015, Mr. Dickson has seen Respondent in several individual sessions and in regular weekly group sex offender therapy sessions.

18. Mr. Dickson prepared a Sex Offender Evaluation/Risk Assessment dated December 15, 2016 that was introduced at Respondent's sentencing hearing. Mr. Dickson opined that Respondent was at very low risk to re-offend. Mr. Dickson also reported that the results of a sexual history polygraph administered to Respondent indicated that Respondent was not a pedophile and had no history of or sexual interest in children or prepubescents. Mr. Dickson also testified at Respondent's sentencing hearing that Respondent has been extremely helpful to other men in his treatment group. Mr. Dickson further testified that he believed Respondent had shown a great deal of change in the last year and a half and that Respondent has pledged to Mr. Dickson and to Respondent's therapy group that Respondent was committed to spending the rest of his life avoiding his addiction to pornography and helping others avoid it.

19. Respondent's conviction constitutes an independent basis for discipline, pursuant to Rule 203 (b) (1), Pa.R.D.E.

SPECIFIC RULE OF PROFESSIONAL CONDUCT AND
RULE OF DISCIPLINARY ENFORCEMENT VIOLATED

Respondent violated the following Rules of Professional Conduct and Disciplinary Enforcement:

RPC 8.4(b), which states that it is professional misconduct for a lawyer to commit a criminal act that reflects adversely on the lawyer's honesty, trustworthiness or fitness as a lawyer in other respects; and

Pa.R.D.E. 203(b)(1), which states that conviction of a crime is a ground for discipline.

SPECIFIC RECOMMENDATION FOR DISCIPLINE

20. Petitioner and Respondent jointly recommend that the appropriate discipline for Respondent's admitted misconduct is a five-year suspension retroactive to the date Respondent was placed on temporary suspension.

21. Respondent hereby consents to that discipline being imposed upon him by the Supreme Court of Pennsylvania. Attached to this Petition and marked Exhibit "A" is Respondent's executed Affidavit required by Rule Pa.R.D.E. 215(d), stating that he consents to the recommended discipline and including the mandatory acknowledgements contained in Rule 215(d)(1) through (4), Pa.R.D.E.

22. In support of Petitioner and Respondent's joint recommendation, it is respectfully submitted that the following mitigating circumstances are present:

- a) Respondent showed remorse and acceptance of responsibility by waiving his preliminary hearing and by pleading guilty to his crimes;
- b) Mr. Dickson's evaluation of Respondent indicates Respondent represents a low risk to re-offend in any sexual manner or by sexually acting out with a child;
- c) Respondent has positively responded to his therapy with Mr. Dickson, and Mr. Dickson believes Respondent has shown a great deal of change in the last year and a half.
- d) Respondent has admitted engaging in misconduct and violating the charged Rule of Professional Conduct and Rule of Disciplinary Enforcement;
- e) Respondent requested and agreed to be placed on temporary suspension as evidenced by his participation in the filing of a Joint Petition to Suspend;
- f) Respondent is remorseful for his misconduct and understands he should be disciplined, as is evidenced by his cooperation with Petitioner and his consent to receiving a five-year suspension;
- g) Respondent has no prior record of discipline;
- h) Attached as Exhibit "B" are seventeen letters submitted to Respondent's sentencing judge from members of Respondent's community attesting to his honesty, good character and remorse; and
- i) Respondent has no prior criminal history.

23. A suspension of five years is appropriate in light of the specific facts of this case and has been imposed in four

cases with similar fact patterns.

In *Office of Disciplinary Counsel v. Robert Vincent Mitchell*, 73 DB 2009 (2012), Mitchell downloaded and viewed on his office computer approximately six hundred images depicting child pornography. The FBI executed a search warrant on Respondent's computer and recovered the images Mitchell had deleted. Mitchell pled guilty to one count of possession of child pornography and was sentenced to thirty months in prison followed by eight years of supervised release. At his disciplinary hearing, Mitchell presented compelling evidence of his efforts to seek treatment for the underlying psychological problems that ultimately led him to pornography. Mitchell's psychologist opined that Mitchell had a good prognosis, a low risk of recidivism and a high probability of readjusting to society. Mitchell also submitted letters from numerous character witnesses. Relying on the five-year suspensions imposed in *Office of Disciplinary Counsel v. Christie*, 639 A.2d 782 (Pa. 1994) and *Office of Disciplinary v. Andrew Malone*, No. 131 DB 2004 (2006), the Disciplinary Board recommended that Mitchell be suspended for five years and that his suspension be prospective because of his lengthy term of supervised release. The Supreme Court suspended Mitchell for five years retroactive to the date of his temporary suspension.

In *Christie, supra*, Christie invited two male minors, ages twelve and fourteen, to his apartment on separate occasions during a ten-day period. Christie provided the minors with alcoholic beverages, showed them x-rated video tapes, and masturbated in their presence. He did not have any sexual contact with the youths. He ultimately pled guilty to thirteen misdemeanor sex counts of sexual harassment, indecent exposure, endangering the welfare of a child and unlawfully dealing with a child. He was sentenced to five years of supervised adult probation. At his disciplinary proceeding, Christie presented expert testimony establishing that he suffered from a psychological disorder known as non-exclusive or regressed homosexual pedophilia, which caused him to be sexually attracted to both minor and adult males. The Disciplinary Board recommended that Christie be suspended for a period of three years and forty-five days. The Supreme Court imposed a five-year suspension, yet still found the following mitigating factors: Christie's criminal conduct was induced by the psychiatric disorder, lack of any prior disciplinary or criminal record, cooperation with authorities, remorse, apology to his victims, continued participation in therapy, and low risk for recidivist behavior.

In *Malone, supra*, Malone was arrested as a result of a sting operation conducted by the Pennsylvania Attorney General's Office. An agent, posing as a mother of two girls aged seven and nine, made arrangements through the internet to meet Respondent ostensibly to engage in various sexual activities with the three females. Respondent appeared at the pre-arranged meeting location with Barbie dolls for the "children", a gift for the "mother", and sexual lubricant and condoms in his possession. Malone entered a plea of nolo contendere to the offense of criminal attempt to commit involuntary deviate sexual intercourse and was sentenced to twelve months less one day of imprisonment and a consecutive five-year term of probation. The Disciplinary Board found that Malone's psychologist's reports established *Braun* mitigation in that he suffered from Avoidant Personality Disorder, Sexual Addiction and Depression which were causally related to his misconduct. In recommending a five-year suspension, the Board also cited the mitigating factors of remorse and acceptance of responsibility, an unblemished record of practicing law for over thirty years, evidence of good character as attested to by longtime friends and colleagues and a positive record of community service. The Supreme Court concurred and suspended Malone for five years.

In *Office of Disciplinary Counsel v. Allan Christopher Smith*, No. 176 DB 2015 (2017), by Order dated May 12, 2017, the Supreme Court granted the Joint Petition in Support of Discipline and suspended Smith for a period of five years, retroactive to October 27, 2015. Smith had pled guilty to one hundred fifty counts of Possession of Child Pornography and was sentenced to county probation for a term of five years. Similar to Respondent herein, Smith showed remorse and acceptance of responsibility by waiving his preliminary hearing, pleading guilty to his crimes and requesting to be placed on temporary suspension. Additionally, Smith positively responded to psychiatric therapy and in the opinion of his evaluators, presented a low risk for recidivism or sexually acting out with a child.

24. Petitioner and Respondent submit that a five-year suspension, retroactive to the date of temporary suspension, February 12, 2016, is the appropriate resolution based upon the specific facts of this case and an analysis of prior cases involving similar criminal misconduct.

WHEREFORE, Petitioner and Respondent respectfully request that, pursuant to Pennsylvania Rules of Disciplinary Enforcement 215(e) and 215(g), a three-member panel of the Disciplinary Board review and approve the Joint Petition in Support of

Discipline on Consent and file a recommendation with the Supreme Court of Pennsylvania that Respondent receive a five-year suspension, retroactive to February 12, 2016, and that Respondent be ordered to pay all necessary expenses incurred in the investigation and prosecution of this matter.







Dear Mr. Ryan:

My name is Gordon Cooney and I am a litigator and partner with a global law firm in Philadelphia. I have been fortunate to appear before the federal or state courts of more than 35 states and I am a Fellow of the American College of Trial Lawyers. I am writing in my individual capacity and not as a representative of my firm.

From 1984-86, I had the high privilege to serve as a law clerk to the Honorable J. William Ditter, Jr., of the United States District Court for the Eastern District of Pennsylvania. I am writing with respect to the pending case involving his son, George Ditter. Judge Ditter did not ask me to write this letter, but I feel compelled to offer some thoughts for your consideration as you contemplate your sentencing recommendation. My purpose is not to comment on the underlying charge or with regard to any defense concerning that charge. Rather, it is to offer more than 30 years of familiarity with the Ditter family.

Apart from my own father, Judge Ditter is, without question, the finest man I have ever known. Although we remained close following my clerkship, when my father passed away in 1999 Judge Ditter took a particular interest in me and he has been like a second father since that time. Judge Ditter is a true patriot, who served in the Navy during the Second World War. He has lived nearly his entire life as a committed public servant, whether in the office where you currently serve, on the bench in Montgomery County, or on the federal bench to which he was appointed in 1970. He followed in the footsteps of his own father, who, among other things, served with distinction in the U.S. Congress.

I admired Judge Ditter as his law clerk. As time has gone by and I have appeared before judges across our country, I have come to appreciate more

fully Judge Ditter's unusual commitment to the law and the judicial process. He cares about every case assigned to his docket, and he evaluates the impact of his decisions on both the law and the people affected by those decisions. During my two years as his law clerk, I saw that nothing consumed Judge Ditter's attention more than arriving at a just sentence in a criminal case.

Judge Ditter has devoted himself to his family, and he brought his law clerks into his family circle. As a result, I had the good fortune to know the Judge's late wife, Verna, as well as their sons and their families. I have known George since my clerkship. George was a frequent visitor to Chambers; I have seen him at Judge Ditter's many gatherings over the years; and the Judge has often talked with great affection about all of his sons, including George, during my regular visits with the Judge. I know that the Judge and Mrs. Ditter instilled in George a strong love of country, commitment to the law, and love of family.


I don't pretend to know how George found himself in the current situation, but I do know that it is discordant with the way he has lived the rest of his life. I also know that it has exacted a heavy heavy toll on George, his family in general and his father in particular. Although the charges and conduct at issue have been truly heartbreaking to the Judge, he continues to love his son without qualification. Watching his family suffer as a result of his decisions has inflicted significant punishment on George. It is inconceivable to me that George would engage in this kind of conduct again.

You know the circumstances far better than I, but I would ask you to consider a sentencing recommendation that does not include incarceration. George has paid a heavy price already. There are alternatives that could serve the public interest. And other forms of sentence could better enable the rest of George's family to both heal and support him as he works to rebuild his life.

I suspect that you likely will need to discuss your recommendation with the District Attorney. I have known and respected him for a long time, as his wife was my friend and colleague at my law firm for many years. I would not presume to reach out to Mr. Steele without your consent, but if either you or Mr. Steele would find it helpful to talk with me about George, I would be happy to do so at your convenience.

Our children (who also support our assessment of George) were in the Perkiomen Valley school system with the Ditter children and we would see each other often at school events, activities, and programs.






George Ditter has been my closest friend for over twenty-five years. He has taught my children in Sunday School at our church. He has represented members of our family for various legal services including the writing up of wills, creating business partnerships, and answering various legal questions.

He is a man of significant moral character. I state that with full conviction, based on his charity, service, leadership, and courage to stand up for and help so many people over the years.

George has always been the person most likely to step in and help a person or organization in need. The Tabor United Methodist Church had a run-down storage shed next to the cemetery that needed to be replaced. The church lacked the funds to repair it. Without being asked, George came over after hours and rebuilt the shed to new condition. He didn't tell anyone. He didn't submit a bill for the materials or the labor. He simply got it done. It was a while before anyone knew who the benefactor had been. This is one example. I could list hundreds.

George has served his community by participating and sometimes leading volunteer organizations. When he led, he did so by example. He organized volunteers and led them faithfully to pick up trash along route 63. He sometimes did this by himself when no one else stepped forward to help. I was one of those who never volunteered. George would occasionally joke about my lack of cart way beautification skills, but never made me feel ashamed in any way for not assisting. He was always focused on getting things done and treating everyone equal regardless of their station or situation. George sang in the choir. Not because his voice was any better than anyone else's but because the choir needed volunteers and George willingly and faithfully participated. George shows tremendous character and leadership skills. Often when a group of us decide to move forward with an idea, George is the person who mindfully pulls us back to first carefully consider alternatives, possible details, and potential pitfalls, especially legal concerns.



At church, George has held several leadership positions, including Trustee and member of Administrative Council. While George served as a Trustee, he began a highway cleanup program along Route 63 from Sumneytown through Green Lane.



George welcomed my family into the congregation with open and loving arms at a challenging time in my family's life. Initially, I only saw George on Sunday mornings where he was always even-keeled and in good spirits. But, as time went on, our families began spending time together throughout the week also.

George participated in many Sunday school classes and bible studies that I was a part over the years. His participation was always very contemplative and he often challenged other group members to dig beneath the surface and truly explore the life lessons that could come from the study. At times, he was the group leader and at other times, he respectfully submitted to the leadership of others. George saw both types of experiences as beneficial and demonstrated the ability to be flexible to others.

George's humor often cut the tension when stress was high. As a Registered Nurse, I consider anyone who can reduce tension in others a tremendous asset. Through the gift of humor, George regularly had a positive stress-reducing influence on others. My name is Richard Hollingsworth. I live at 1517 Safford Station rd., Harleysville, Pa 19438. My phone number is (610) 287-5239.


