This is an appeal by the appellant, David C., from an order terminating his parental rights to his minor child of the same name. The order terminating the appellant=s parental rights was entered on April 29, 2016. The Notice of Appeal was not filed until June 1, 2016, more than thirty (30) days from the date of entry of the final order. The Attorney General, on behalf of the appellee, Tennessee Department of Children=s Services, has filed a motion to dismiss this appeal based upon the untimely filing of the Notice of Appeal. Because the Notice of Appeal was not timely filed, we have no jurisdiction to consider this appeal and grant the motion to dismiss.

MEMORANDUM OPINION¹

A notice of appeal must Abe filed with and received by the clerk of the trial court within 30 days after the date of entry of the judgment appealed from. Tenn. R. App. P. 4(a). AThe thirty-day time limit for filing a notice of appeal is mandatory and jurisdictional in civil cases. Albert v. Frye, 145 S.W.3d 526, 528 (Tenn. 2004). The appellant has filed no response to the motion to dismiss and the certified copy of the final order attached to the motion confirms that the date of entry of the final order was April 29, 2016.

Because the Notice of Appeal in this case was not timely filed, we lack jurisdiction to consider this appeal. The motion to dismiss is granted and this appeal is dismissed. Costs on appeal are taxed to the appellant, for which execution may issue if necessary.
