MEMORANDUM OPINION

Appellants appeal the trial court's December 12, 2024 judgment. In a motion for an extension of time to file the record, appellants informed the Court that the trial court had signed an order vacating the December 12 judgment.¹ On April 30, 2025, we denied the motion and, noting there was currently nothing before the Court to review, we informed appellants that we would dismiss the appeal for want of
