On December 4, 2000, Pablo Rodriguez pleaded guilty to engaging in organized criminal activity. The district court deferred further proceedings and placed Rodriguez on community supervision. Rodriguez filed his original notice of appeal on January 5, 2001. He filed a supplemental notice on February 14, 2001.

The deadline for perfecting appeal was January 3, 2001. Tex. R. App. P. 26.2(a)(1). No extension of time for filing notice of appeal was requested. Tex. R. App. P. 26.3. There is no indication that notice of appeal was properly mailed to the district clerk within the time prescribed by rule 26.2(a). Tex. R. App. P. 9.2(b). Under the circumstances, we lack jurisdiction to dispose of the purported appeal in any manner other than by dismissing it for want of jurisdiction. *See Slaton*
