#### MEMORANDUM OPINION PER CURIAM

Michael Ray Timmons pleaded "guilty" to aggravated kidnapping, assault family violence, and sexual assault, all enhanced by prior convictions, and the trial court sentenced him to thirty years in prison for each offense, to run concurrently. Appellant appealed.

The clerk's record has been filed and each of the trial court's certifications state that these are plea bargain cases and the defendant has no right of appeal. The certifications are signed by Appellant and his counsel. *See* TEX. R. APP. P. 25.2(d). Appellant also signed a waiver of appeal in each case.

When the defendant is the appellant, the record must include the trial court's certification of the defendant's right of appeal. *Id*. This Court must dismiss an appeal "if a certification that shows the defendant has the right of appeal has not been made part of the record." *Id*. Based on our review of the record, the trial court's certifications appear to accurately state that these are plea bargain cases and Appellant waived his right to appeal. *See Dears v. State*, 154 S.W.3d 610 (Tex. Crim. App. 2005) (holding that court of appeals should review clerk's record to determine

whether trial court's certification is accurate). Because the trial court did not grant Appellant the right to appeal his convictions, we *dismiss* the appeals.
