Dennis Ray Harrison appeals a decision of the Workers' Compensation Commission finding that he failed to prove (1) his psychological condition is either a compensable occupational disease or a compensable ordinary disease of life; and (2) he is totally incapacitated for all work due to that condition. We have reviewed the record and the commission's opinion and find that this appeal is without merit. Accordingly, we affirm for the reasons stated by the commission in its final opinion. See Harrison v. Commonwealth of Virginia/Dep't of Mines.
